ORDER

Various unaided Training Colleges affiliated to this University have requested vide paper (1) read above, for granting the extension of provisional affiliation of the colleges and courses for the academic year 2019-20. University had constituted Inspection Commissions to assess the infrastructural and instructional facilities available with the following unaided training colleges in order to consider the matter of granting extension of provisional affiliation of the colleges and courses for the academic year 2019-20, vide paper read as (2) above.

The Inspection Commissions which visited the colleges have favourably recommended for extension of provisional affiliation to Avila College of Education, Edacochin, Mar Severios College of Teacher Education, Chengaroor, St.Thomas College of Teacher Education, Mylacompu, Thodupuzha and the courses in that colleges for the academic year 2019-20. Considering the above, the Syndicate of the University, vide paper (3) read above, had recommended to extend the provisional affiliation to this three colleges for the academic year 2019-20 subject to the condition that the colleges shall get extension of approval from NCTE for the academic year 2019-

20.

In the case of Porukara College of Education, Champakulam, Alapuzha the Commission had found that the college is functioning at the same building of the Arts & Science College & they both sharing the library and other facilities. Hence the Syndicate of the University vide paper (3) read above decided to extend the provisional affiliation to this college only after receiving an affidavit from the manager of the college. Accordingly the college has submitted the affidavit as follows.

'As per the instruction of the University, the college will construct a new building with all academic and physical facilities. The construction will be completed before 31st March 2020.'

Therefore, sanction is accorded for the extension of provisional affiliation to the above four unaided training colleges and the courses as detailed in the table above.
